### CELEBRATING THE 50TH ANNIVERSARY OF THE WILDERNESS ACT



Join us on May 21 for our final 2014-15 ASC program. Our speaker, Bridget Callahan, will present: Celebrating the 50th Anniversary of the Wilderness Act -Successes and New Opportunities. Protection of

our wild lands is a priority for Audubon, and it is fitting for us to commemorate the 50th anniversary of the Wilderness Act.

Bridget Callahan is the Wilderness Organizer for Oregon Wild, a 40-year-old conservation organization working to protect Oregon's wild lands, wildlife and waters. A native Oregonian, Bridget has worked in the political and environmental sectors to protect the quality of life we all enjoy. At Oregon Wild she works across the state to highlight the wonders of Crater Lake and other public lands, and to see that these areas are protected for future generations to enjoy.

#### MAY THROUGH SEPTEMBER

### ASC BOARD ELECTIONS

The Board of Directors of the Audubon Society of Corvallis is offering the following slate of candidates for the 2015/2016 term, which begins at the summer board meeting (date to be set in May).

**President- Chris Mathews** is currently serving ASC as Vice President and President Pro Tem. Chris moved to Corvallis in 1978 with wife Kate, to assume the chairmanship of the Department of Biochemistry and Biophysics at OSU, after previous service on the faculties of Yale University and the University of Arizona. He retired from OSU in 2002, but continues with part-time teaching, writing, and reviewing. He served as President of ASC from 2005 to 2008. Currently he also serves as Vice-President of the Great Basin Society; a nonprofit corporation that oversees Malheur Field Station.

**Vice President- Bill Proebsting** is a retired professor of horticulture at OSU and long time bird watcher. He served on the ASC board in 2003-05 and presently leads local second Saturday field trips for the chapter. He particularly enjoys birding Benton county, but he and Lena travel periodically around the U.S. and to Latin America. He also birds by bicycle for a motorless birdathon for Hesthavn.



**Secretary- Gail Nickerson** is a native Oregonian who has lived in Corvallis for most of her life. She joined the ASC after retirement to learn more about backyard birds. She has served as Refreshment Chair, board member at large, and currently as ASC secretary.

**Treasurer- Fred Ramsey** co-founded ASC in 1970, was its first president, and served in this position again in the 1980s. He is our current Treasurer. Fred has led weekend field trips since 1971, edited the Chat and served in many other positions. As a world-traveled and respected ornithologist, his other interests include music, theatre, fishing and baseball. Fred is also Professor Emeritus of Statistics at OSU. His many publications include *Birding Oregon*, one of the first site guides, published by ASC in 1978.

#### MEMBERS-AT-LARGE:

**Linda Campbell** moved from San Juan Island, WA, back to her native Willamette Valley in 2004. She has been active in ASC since then, primarily in the effort to get the Homer Campbell Memorial Trail boardwalk built at Finley Wildlife Refuge, and as Board secretary and Member-at-Large. Linda works at OR Department of Fish & Wildlife.

**Marie Martin** is currently serving as a Member-at-large, has been an active participant in numerous ASC field outings, fills in at the book and raffle table, and is rarely found without binoculars in hand. Recently retired as a pharmacist (you might have met her when she worked downtown at the old Albright and Raw Pharmacy), Marie applies the same detailed attention to birding and her hobby as a fledgling wildlife artist. Formerly of Santa Cruz, CA, in 1992 she attended Pharmacy School at OSU so she could explore the natural beauty of Oregon. She is pleased to be nominated again as an at-large board member of ASC.

**Teri Engbring** joined the Board as an at-large member 2 years ago, and has been an active ASC volunteer with our Education and Outreach programs since moving to Corvallis in 2012. She is a retired Environmental Educator who worked with schools in WA state, CA Dept of Fish and Game, and non-profit foundations, designing curriculum, teaching, and coordinating volunteers in education and conservation programs. She is also editor of the Chat newsletter and enjoys birding and world travel.

**Spencer Mair** is the founder and past events chair of the OSU Bird Nerds. He grew up in Sacramento, CA, growing his love for birds, and wildlife, on the Sacramento Wildlife Refuge. He banded birds at Big Sur, participated in curlew nest surveys at Malheur and Common Murre studies at Yaquina Head, did point counts on farms in the Willamette Valley, helped with the Oregon 2020 project, and numerous birdathons. He has been an active member of the Corvallis Audubon Society for four-plus years and has enjoyed serving as a member-at-large for the past year and learning about bird conservation and improving and protecting bird habitat.

**Jim Parr Philipson** has been active in ACS since 2011, participating in the monthly field trips, bird-a-thon and trips to Malheur. Birding became a passion for Jim when he moved to Corvallis in 2010 with guidance from friends, Bill Proebsting and Ken Hilton. He and his wife, Bonnie,

recently retired as United Methodist clergy. He is active in homeless issues in Corvallis.

**Mark Baldwin** has lived in Corvallis since 1981. He grew up in southeastern Washington as a frustrated upland game bird hunter. He decided to leave his gun at home, and has been a recreational birder for forty years. Since his 2013 retirement from the Corvallis School District (Applied Tech-woodworking to engineering & robotics), he has been birding almost daily with camera in hand for "capturing" birds. He has been an active participant in the Oregon 2020 project and though he has only recently become active in ASC, he looks forward to contributing to the preservation of our natural world in more meaningful ways.

#### Alternate member-at-large:

**Will Wright** has served as ASC President and Member-at-Large and is a 3rd/4th grade teacher. He has been a teaching interpretive naturalist at Mt. St. Helens, biology instructor for O.M.S.I., instructor at Camp Hancock, Outdoor School, and staff member for Puffin Project in Maine for National Audubon Society. He spent one year following Spotted Owls with radios; two seasons doing cavity nesting bird surveys; and four seasons doing Marbled Murrelet surveys. He has traveled for birding and education in Alaska, Canada, Mexico, Guatemala, Costa Rica, Panama, Ecuador, Hawaii, Japan, India, Nepal, Kenya, and Europe.

## FIELD NOTES

3/24/15-4/28/15

Unusually warm, dry spring weather continued, with just light frosts on 4 & 5 Apr. **Black cottonwoods** at EEW were fully leafed out by 1 Apr when the leaves on **Oregon white oaks** began to unfurl.

Finley NWR, JFW = Jackson-Frazier Wetland, LSNA = Luckiamute State Natural Area, McFadden (Marsh) at FNWR, PCT = Pacific Crest Trail, PSTP = Philomath STP, Stewart Lake = lake on Hewlett-Packard (HP) campus in Corvallis, TCP = Teloh-Calapooia Park in Albany, TWG = Talking Water Gardens in Albany.

**Greater White-fronted Goose** migrant flocks were noted from 17 Apr thru the end of the period (m.obs.). At Finley 200 resting 18 Apr were scared up by a **Bald Eagle** (MMo), and another flock lined up to pick grit off of the road 20 Apr (PRz). 2000 flew north over Corvallis in the space of half an hour 21 Apr (HH). 2800 passed NNW over LSNA and 450 more over EEW on 23 Apr (JGe). Huge flocks of thousands also flew over Corvallis 23 Apr (JPh) and over Albany all day 26 Apr (Chi).

Two white geese in a field e. of the HP campus 1 Apr were most likely **Snow Geese** (LM, DBo). A Snow Goose was at FNWR 26 & 27 Apr (HH, OH, THy; WW); a **Ross's Goose** was there 22 Apr (WW). A few **Dusky Canada Geese** stayed at FNWR thru 2 Apr (LM). **Western Canada Goose** goslings were out of nests at EEW by 28 Apr. 7000 **Cackling Geese** were still at McFadden 26 Apr (HH, OH, THy). Two **Tundra Swans** lingered near LSNA thru 7 Apr (JGe).

**Wood Ducks** were on a lake and in a big-leaf maple in Simpson Park 17 Apr (RFo). Two families of **Mallard** ducklings swam on Periwinkle Creek in Albany 29 Mar (DEm). **Cinnamon Teal** were numerous at McFadden by 15 Apr (HH, OH).

A few **Northern Pintail** continued near FNWR thru 2 Apr (LM). Two **Lesser Scaup** on Apr 9 were the last of season at Stewart Lake (JSi). A **Harlequin Duck** pair loafed along the S. Santiam River at House Rock CG 11 Apr (DCg).

**Sooty Grouse** boomed on Marys Peak 26 Mar (PCo, RCo) and at Lost Prairie CG 11 Apr (DCg). **Mountain Quail** called from the slopes of Soap Creek Valley 26 Mar and in the Highland Dell area of Corvallis 4 Apr (LM; MG).

A **Common Loon** and **Horned Grebes** were on Foster Res. 11 Apr (Donald Cogswell). By 4 Apr one of two **Horned Grebes** at PTSP was in full breeding plumage (OH, HH, AHk, CHk, PO); at least one continued there thru 25 Apr (HH, OH, THy). Two **Eared Grebes** there were mostly in breeding plumage by 2 Apr (HH); sightings continued thru 25 Apr (WW; PO; HH, OH).

**American Bitterns** were detected regularly in marshes at FNWR from 15 Apr onward (WW; PRz; m.obs.). A **Green Heron** at Stewart Lake Apr 17 was the first of season for that location (JSi); another was at Willamette Park 26 Apr (HH, OH, THy).

Marys Peak was a surprising place to see an **Osprey** 26 Mar (PCo, RCo); one over Stewart Lake 26 Mar (JSi) was in a more customary location. Three calling at LSNA 15 Apr sparked replies from a **Greater Yellowlegs** near the Santiam River confluence (HB). **Bald Eagles** included 3 adults and 2 juveniles e. of Albany 26 Apr (Chi, JHi), and a pair in courtship at LSNA 26 Apr.

One of a **Cooper's Hawk** pair frequenting a yard near TCP carried willow branches into the forest 3 Apr (JDS). A young **Northern Goshawk** tried to nab a Band-tailed Pigeon sw of Philomath 26 Mar (JiF, KnF). **Red-shouldered Hawk** pairs are nesting near Covered Bridge along Campus Way and at Sunset Park in Corvallis, where one was carrying sticks to an apparent nest site 3 Mar (AHk). Two **Rough-legged Hawks** were still at FNWR 29 Mar (PO); one still hovered over the north prairie 2 Apr (LM).

Three **Virginia Rails** were at Bald Hill Park just south of Oak Cr. 23 Apr, in a wet area produced by **Beaver** activity along Oak Creek (MAI). A **Sora** called along Campus Way 31 Mar (AHk); others were regular at FNWR thru the period. A **Sandhill Crane** foraging on the prairie at FNWR 17 Apr (WW) continued thru the end of the period (LHa; HH; BPT).

Two **Black-necked Stilts** were at BSNWR 26 Apr (LHa). An **American Avocet** turned up there 24 Apr (BTi). Four **Black-bellied Plovers** were at FNWR 9 Apr (WW). A **Semipalmated Plover** was at Cabell Marsh 26 Apr (HH, OH, THy). A **Killdeer** nest near Albany held four eggs by 28 Mar (DEm); hatchlings were noted at BSNWR by 6 Apr (FrK).

**Spotted Sandpipers** turned up at Willamette Park (a nesting site) 17 Apr (HH) and at Stewart Lake Apr 28 (JSi). **Solitary Sandpipers** made a remarkable showing at Sunset Park with up to 6 there 19-20 Apr, 7 on 23 Apr and ten or eleven on 25 Apr (AHk, CHk; HH). Passage of **Greater Yellowlegs** continued thru the period, with a high count of 45 at McFadden 15 Apr (HH, OH). Single **Lesser Yellowlegs** were at a conservation wetland near FNWR 2 Apr (LM), along Bruce Rd 15 Apr (HH, OH), at TWG 17 Apr (RFo), and at Cabell Marsh 26 Apr (HH, OH). A few **Dunlin** continued thru the period with 25 at Cabell Marsh 28 Apr (HH). 47 **Least Sandpipers** were at PSTP 2 Apr (HH) and 80 were at Cabell Marsh along with 15 **Western Sandpipers** and 40 **Long-billed Dowitchers** 28 Apr (HH). A **Wilson's Snipe** lingered at Sunset Park 19 Apr (AHk, CHk).

A **Bonaparte's Gull** was seen by the ASC field trip to BSNWR 11 Apr (MG); one was at PTSP 12 Apr (WW).

The **Band-tailed Pigeon** flock visiting feeders at Alder Spring sw of Philomath swelled to 40 by 26 Mar and over 100 by 14 Apr (JiF, KnF).

A **Western Screech-Owl** sang on Marys Peak 26 Mar (PCo, RCo). Another was heard four times at Hesthavn 16-27 Apr (JGi). **Great Horned Owls** were nesting at PSTP by 3 Apr (WW). Other owls included a **Northern Pygmy-Owl** tooting on Marys Peak 26 Mar (PCo, RCo), a **Barred Owl** calling regularly up on Witham Hill thru 16 Apr (JGi), and a **Northern Saw-whet Owl** tooting on Kiger Island in mid-Apr (fide BGa).

**Vaux's Swifts** showed up over Corvallis 13 & 14 Apr (AHk; LPN; KH). Hundreds used a chimney at 1st and Van Buren in Corvallis 26 Apr (LDu fide MG). 1597 were counted going to roost in the Albany fire station chimney 26 Apr (LSc).

Male **Calliope Hummingbirds** turned up near TCP 23 Apr (JDS), in s. Corvallis 25-27 Apr (WFz), and near the OSU campus 27 Apr (HH). **Rufous Hummingbirds** continued to be seen in good numbers with at least 6 visiting an Oak Cr. yard 26 Mar (BPr). An imm. male with greenish back was in Corvallis 18 Mar (NNy).

A **Red-breasted Sapsucker** worked on a nest hole near TCP 29 Mar (JDS). An **American Three-toed Woodpecker** was s. of Big Lake near Santiam Pass 5 Apr (JSu, LJo). A female **Yellow-shafted (Northern) Flicker** was at EEW 25 Mar (JGe).

A very dark **Merlin** squabbled with a female **American Kestrel** over a perch at FNWR 2 Apr (LM). Reports of **Merlins** around town continued thru 9 Apr when one was on the OSU campus (DBo). A **Peregrine Falcon** flew over n. Corvallis 13 Apr (LM, DBo) and one was at FNWR 15 Apr (HH, OH).

Migrant flycatchers began to show up, with a **Hammond's Flycatcher** at FNWR 15 Apr (HH, OH) and a **Pacific-slope Flycatcher** sw of Philomath 17 Apr (KnF). The now-resident



**Black Phoebes** also moved around a bit, with birds noted at Stewart Lake 26 Mar (JSi), at the Corvallis water treatment intake in Willamette Park 2 Apr (LM), and near McFadden 13 Apr (AIC). Two **Western Kingbirds** sallied after flying insects near the prairie overlook at FNWR 25-26 Apr (WW; HH).

A **Loggerhead Shrike** was at BSNWR 25-26 Mar (BW, PO; DNa).

Early **Cassin's Vireos** sang near Monmouth 13 Apr (Olin Allen) and along Muddy Creek at FNWR 15 Apr (HH, OH). A **Warbling Vireo** sang at Cardwell Hill 20 Apr (BA); migrants were numerous at Willamette Park by 26 Apr (WW).

40 "**Streaked**" **Horned Larks** continued s. of Monmouth thru the end of the period (MLi).

**Purple Martins** turned up at nesting sites e. of Scio 13 Apr (PWa), sw of Philomath 14 Apr (JiF, KnF), and around 16 Apr on Dunn Forest (DVy) where four were near the nesting "gourds" along the 110 Rd on 25 Apr (PCo). **Tree Swallows** defended nest boxes thru the period. A pair of **Violet-green Swallows** started building a nest near TCP by 15 Apr (JDS). **Northern Rough-winged Swallows** turned up at Willamette Park 2 Apr (LM) and at PTSP 4 Apr (OH, HH, AHk, CHk). A **Cliff Swallow** was of Monmouth 30 Mar (MLi); many were at PTP along with numerous **Barn Swallows** on 2 Apr (HH).

A pair of **Black-capped Chickadees** quickly occupied a new bluebird nest box at the Oddfellows' Cemetery in mid-Apr (JCr). Meanwhile pair of **Chestnut-backed Chickadee** claimed a nest box normally used by Black-capped Chickadees in N. Albany 8 Apr (CHi). A male **Bushtit** peeked out of nest in Willamette Park 2 Apr (LM).

A pair of **Bewick's Wrens** took up quarters in an old nest box in n. Corvallis, and on 23 Apr one carried a fecal sac out of the box (MC). Early **House Wrens** were noted on Baskett Butte 28 Mar (BA), at FNWR 2 Apr (BPr), sw of Philomath 4 Apr (KnF), and at Bald Hill Park 10 Apr (AHk). **American Dippers** tended a nest under the bridge at the Alsea Fish Hatchery 4 Apr (OH, HH, AHk, CHk). A few **Ruby-crowned Kinglets** were still singing sw of Philomath 18 Apr (KnF, JiF), but most migrated out by the end of the period, while many **Golden-crowned Kinglets** will stay to nest.

A pair of **Western Bluebirds** in the Cheldelin neighborhood had to fend off House Sparrows, chickadees and swallows but persevered and laid their first egg 11 Apr and second on 12 Apr (LM, DBo). A pair of **Mountain Bluebirds** were just below the summit of Marys Peak 31 Mar (DFx, LFx). A lingering **Hermit Thrush** was at Willamette Park 26 Apr (HH, OH, THy). A **Varied Thrush** also lingering in the valley sang at LSNA 10 Apr (JGe); six were moving through the foothills sw of Philomath 17 Apr (KnF, JiF).

An adult **White Wagtail** (apparently ssp. *ocularis*) was found 29 Apr during surveys for **Streaked Horned Larks** at BSNWR (JDp, NRi, BW, m.obs.). The closest place where these birds nest is in the Bering Strait region of Siberia and Alaska. The wagtail was foraging in the company of a flock of **American Pipits**, its distant relatives.

Three **Cedar Waxwings** at Stewart Lake 30 Mar were the only ones noted there for the period (JSi); about 20 migrants were on the OSU campus 13 Apr (AHk).

Nine **Orange-crowned Warblers** were singing along the bike trail between Fitton Green and Bald Hill Farm 27 Mar (RCo). Migrants were numerous at Willamette Park 26 Apr

(WW). A **Nashville Warbler** stopped by Sunset Park 25 Mar (HH, OH, THy). An early **Yellow Warbler** visited Sunset Park 19 Apr (AHk, CHk). More were singing at EEW 25 Apr and at Willamette Park 26 Apr (JGe; HH, OH, THy). **Yellow-rumped Warblers** were also on the move; a bright male "**Audubon's**" **Warbler** visited a suet feeder in Corvallis 26 Mar (MRi) and migrant "**Myrtle**" **Warblers** were also noted thru the period.

Singing **Black-throated Gray Warblers** turned up sw of Philomath and along Campus Way 6 Apr (JiF, KnF; AHk). **Hermit Warblers** arrived sw of Philomath 17 Apr (KnF) and along Bellfountain Rd near FNWR 26 Apr (HH, OH, THy). **Townsend's Warblers** seemed to be sparser than usual in the mid-valley this winter and into early spring, though a few visited suet feeders or were heard around town (GPT; ESh; CHk). As April wore on, migrants were heard singing in widespread locations (m.obs.). A **MacGillivray's Warbler** was along Bellfountain Rd. s. of the FNWR entrance 16 Apr (WW); one was sw of Philomath 18 Apr (KnF, JiF), and single migrants were noted at Willamette Park 17 Apr (HH) and Sunset Park 19 Apr (AHk, CHk). **Common Yellowthroats** continued to arrive with one at FNWR 25 Mar (DRo) and three in S Corvallis 26 Mar (BPr). A migrant found dead apparently after flying into the side of a barn near Albany 30 Mar (DEm). **Wilson's Warblers** kept up the trend of early arrivals, with one at Bald Hill Park 10 Apr (AHk), one Apr 13 at Stewart Lake (JSi), and one sw of Philomath 14 Apr (JiF, KnF). One hovered to glean insects from hellebore flowers in a NW Corvallis yard 22 Apr (SHg). A **Yellow-breasted Chat** sang at FNWR 28 Apr (MB).

**Western Tanagers** were heard at FNWR 26 Apr (HH, OH) and in Corvallis 28 Apr (LPN).

**Chipping Sparrows** began to show up with one in the Cheldelin neighborhood 29 Mar and one singing on Bald Top at FNWR 2 Apr (LM). Numbers at OSU's Soap Creek Ranch exceeded 20 by 24 Apr. A **Vesper Sparrow** sang at Bald Hill Farm 27 Mar (RCo). Three were there by 1 Apr (MBS). Many **Savannah Sparrows** were singing on territory by the end of the period, but many migrants were still moving through.

A lingering **Fox Sparrow** sang at Willamette Park 17 Apr (HH). Nine migrant **Lincoln's Sparrows** were at Sunset Park 19 Apr (AHk, CHk). A **Swamp Sparrow** was still at LSNA thru 10 Apr (JGe).

Lingering **White-throated Sparrows** included 2 thru 22 Apr and 1 thru the period in nw Corvallis (JSi), and one at Willamette Park 26 Apr (HH, OH, THy). One wintering s. of Philomath left on 27 Apr (VSt). Migrant **White-crowned Sparrows** moved on, last seen in a nw Corvallis yard Apr 23 (JSi). Meanwhile nesting birds settled in; a mating pair were noticed in a hawthorn at LSNA 26 Apr (BGa). Some observers noticed that wintering flocks of **Golden-crowned Sparrows** left yards around 26-27 Apr (JSi; VSt) but a few remained thru the end of the period. A male **Slate-colored (Dark-eyed) Junco** visited a nw Corvallis yard twice on 26 Apr after other juncos had left (JSi).

Our loudest migrants, **Black-headed Grosbeaks** showed up with singles near TCP 21 Apr (JDS), in Lacombe and near Fitton Green 24 Apr (ABk; PCo). Reports were widespread by the end of the period. A **Lazuli Bunting's** flight call was heard over Corvallis at 11 PM 20 Apr (CHk); several were at FNWR by 27 Apr (BPr).

**Yellow-headed Blackbirds** turned up at FNWR by 15 Apr (WW). **Brown-headed Cowbirds** started to be noticed away

from wintering locations by 2 Apr; by 26 Apr they were abundant. An early **Bullock's Oriole** was on Baskett Butte 19 Apr (BA); one was at FNWR 26 Apr (HH, OH, THy).

At least 100 **Pine Grosbeaks** continued in the Santiam Pass area 5 Apr (JSu, LJo); some still there 11 Apr (DCg). **Purple Finches** sang thru the period. **Red Crossbills** were noted around Corvallis throughout the period by many observers; 30 fed on sweetgum tree seeds on the OSU campus 13 Apr (MLK). **Pine Siskins** sang in n. Corvallis 10 Apr (LM). **Lesser Goldfinch** males were doing display flights and **American Goldfinch** males were sporting lemon-bright plumage by 9 Apr (LM). **Evening Grosbeaks** arrived in numbers in downtown Corvallis on 29 Mar (RMo). On the OSU campus, at least 600 were around by 23 Apr (AHk), and "clouds" of them were vocalizing on 25 Apr (MG).

Several **House Sparrow** males courting a female in n. Corvallis didn't notice a neighborhood cat that crept up and caught one of the suitors 29 Mar (LM).

**The next Chat** will be the summer issue. We can still look forward to our latest migrants including several flycatcher species and nighthawks, plus lots of excitement from the activities of nesting birds. ## CONSERVATION CORNER

### PROTECT THE GREATER SAGE-GROUSE

The Greater Sage-Grouse is one of the most iconic and imperiled bird species of the American West. It has already disappeared from a number of states and provinces, and its population in Oregon has declined precipitously. Now, in spite of the urgent need to protect it, the U.S. Congress, via a rider added to must-pass legislation, has approved a bill that prevents the possibility of protecting the grouse under the Endangered Species Act. Meanwhile, management plans are underway that have yet to address findings of government scientists, which indicate that saving the grouse will require both protecting large areas of habitat and limiting future energy development.

Eleven leading sage-grouse scientists sent a letter in March to Interior Secretary Sally Jewell and Agriculture Secretary Tom Vilsack noting that current sage-grouse conservation measures in the draft agency conservation plans inconsistently apply the best available scientific information on Greater Sage-Grouse, and will not adequately protect them from further decline.

Please send a letter(s) to our leaders in Washington, urging that they stand up for the Endangered Species Act and science-based management plans, and oppose further delays in the conservation of Greater Sage-Grouse. On April 21st, the bluebird trail volunteers traveled to Salem to present "The Secret Life of Bluebirds" to a gathering of about 60 people. Many excellent questions were asked. One of our new volunteers, Heaven Roberts, made up a wonderful brochure on the topic of Citizen Science, complete with several on-line resources for learning, blogging and reporting. As always, I am very grateful for the enthusiasm and support of our volunteers.

So far, our bluebirds are off to an interesting start this nesting season. We had several very

early nestings, followed by a quiet period. The remaining nesting pairs seem to be starting later than usual. In Linn County, there was an ice storm in mid-November last year that had me wondering how our bluebirds would fare. So far, it seems our numbers are down somewhat, perhaps as much as 20%. Of the banded birds I had known well, we lost a 7 year old male, a 5 year old and two 4 year olds. We'll have an update for the mid-summer Chat.

## AMERICAN BIRD CONSERVANCY:

### SPRING MEANS EASY PREY FOR OUTDOOR CATS

With spring now here, baby birds and other young wildlife will soon be arriving and later venturing from their nests in a generally defenseless state. ABC is reminding cat owners that even the most well-fed domestic cats pose serious threats to vulnerable wildlife. "Spring is an incredibly dangerous time for wildlife because newborn prey don't have the same physical defenses as their parents and have not fully developed the danger awareness regarding predators that comes with time," said ABC Invasive Species Program Director Grant Sizemore. "Spring is perhaps the single most important time of the year for cat owners to protect wildlife by keeping their cats indoors or under their direct control," he said. ### FORAGE FISH PROTECTION TO BENEFIT PACIFIC SEABIRDS

The Pacific Fishery Management Council, which regulates federal waters off California, Oregon and Washington, has voted to adopt measures protecting forage fish that are vital for a wide variety of birds. The preliminary preferred alternative will amend the Council's Fishery Management Plans and identify these species as "ecosystem component" species thereby prohibiting directed harvest without a full scientific review. American Bird Conservancy sent a letter to Council in support of this action and included an article about this conservation effort in the Feb. 2015 issue of Bird Calls (p. 11).
